What you need to know:

1. You are applying to be a member of the Joyful Voice Community Choir Society, an incorporated non-profit society created to operate the choir. Your membership is for the duration of this choir session. In addition to participating in the choir, you are eligible to vote at general meetings and run for election to the board.
2. Choir members have the opportunity to participate on a variety of committees (e.g. social, staging, concerts, etc.).
3. Music is the property of the choir. You agree to return it at the end of the session. You must provide a plain black 1" 3-ring binder for your music (punch available at rehearsal), and bring a pencil to each rehearsal in order to mark your music in accordance with instructions from the music director.
4. We communicate with choir members via email. If you do not have an email address, you are responsible for finding a buddy who will contact you when choir emails are distributed.
5. Your personal information is collected solely to facilitate your membership. It will not be distributed, sold or otherwise disclosed without your express consent.
6. We also provide information to choir members via the Members Only page on our website. We will provide you with the login ID and password at the first rehearsal of the season. You'll find minutes of our meetings, our constitution and bylaws, the schedule for the season, and concert information on this page.
7. Choir rehearsals and events may be recorded, photographed and/or filmed. Such media may be distributed, published (including on our website or Facebook page) or sold at the sole discretion and for the sole benefit of the Joyful Voice Community Choir Society. Individual members hereby consent and waive all rights to ownership and/or compensation.
8. Membership fees are non-refundable.
9. Rehearsal Attendance: Regular attendance at rehearsals is critical in order to keep up with the learning of music throughout the session in preparation for our concerts. We understand that life happens, however, if you miss more than 3 rehearsals during a session, you must consult with the music director about your ability to sing in the concerts.
10. Dress Rehearsal Attendance: This full run-through of our concert is mandatory for all choir members who intend to sing in the concerts. If you are unable to attend dress rehearsal, you must consult with the music director about your ability to sing in the concerts.
11. Concert Attendance: Participation in the final concerts is expected of all choir members. The choir we build throughout the season is the choir we want to hear on concert night. If you are unable to attend one or both of the final concerts, you must consult with the music director at the first rehearsal.
12. You will receive a copy of this information with your membership fee receipt, which will be sent to you by email.
